Dear Kids & Us Families,

I am pleased to share that Kids & Us Community Childcare and Family Education Centres has enrolled in the Canada-Wide Early Learning and Child Care (CWELCC) System between the Province of Ontario and the Government of Canada, effective October 1, 2022. Participating in the CWELCC System will help us continue to provide high quality child care that is accessible, affordable, inclusive, and sustainable.

As a first step we will be reducing base fees effective October 3, 2022 (See chart below) meaning any fee or part of a fee that is charged in respect of a child for child care, including anything a licensee is required to provide under the Child Care and Early Years Act, 2014 (CCEYA), or anything a licensee requires the parent to purchase from the licensee.

Fee reduction through the CWELCC is for children under six years old (a child is eligible until the end of the month in which they turn 6 years of age), retroactive to April 1, 2022. This means that we will be providing eligible families with a credit on your account for fees equal to the amount of the decrease to which you are entitled between April 1 and September 28, 2022. More information on credits will be provided in the near future.

The Ontario child care fee subsidy program will also continue to be available for eligible families.

As we move forward, we will continue to communicate more details to you. If you would like more information about the CWELCC System, please visit the [Canada-Ontario early years and childcare agreement](#) website.
